# Terms of Agreement

1. Casino Services Publishing LLC agrees to produce CasinoFest 9 on May 16, 17, 18 & 19 at Hard Rock Hotel & Casino Tulsa, Catoosa, OK, and to provide the Exhibitor the use of space described and indicated on the official floorplan of the Exhibition area. If Hard Rock Hotel & Casino, or a portion thereof, shall be destroyed by fire or damaged by fire or other calamity so as to prevent the use of the premises for the purposes, and during the period specified herein, or if the premises cannot be used, or it would be impossible, impractical or inadvisable to hold the event, because of strikes, acts of God, national emergency, any act of, or threat of, or fear of terrorism or use of any biological, chemical, radioactive or nuclear agent, material, device or weapon, or other cause beyond the control of Casino Services Publishing LLC, then this Agreement shall terminate and the Exhibitor hereby waives any claim against Casino Services Publishing LLC for damages by reason of such termination.
2. Exhibitor agrees to protect, indemnify and hold harmless and defend Casino Services Publishing LLC from all liability, damage or expense by reason of injury sustained by anyone or by any reason of damage done to property in or about the exhibit area used by Exhibitor, excluding that caused by or resulting from the negligence of Casino Services Publishing LLC or its agents, servants or employees.
3. Exhibitor and Casino Services Publishing LLC agree that the relevant sections of the Agreement entered into between Casino Services Publishing LLC and Hard Rock Hotel & Casino relating to the exhibition premises, as well as the Exhibition Information Sheet for CasinoFest 9, shall be considered part of this contract, incorporated herein by reference, and shall be fully binding on both parties hereto. Exhibitor has read and understands the Exhibition Information Sheet for CasinoFest 9 and agrees to any modifications and amendments to such information hereafter.
4. Exhibitor further agrees to use the exhibit area for the purpose of exhibiting products and/or promoting services, all pursuant to the provisions of the Exhibition Information Sheet for CasinoFest 9. Exhibitor further agrees to pay the balance of the booth rental concurrent to entering into this Agreement.
5. In the event of cancellation of this Agreement by the Exhibitor, Exhibitor agrees to forfeit payments already made. In the event of the Agreement being cancelled by the Exhibitor, Exhibitor agrees that Casino Services Publishing LLC shall have the right to use the subject space to suit its own convenience, including the selling of such space to another exhibitor without any rebate or refund to Exhibitor.
6. The name of the Exhibitor must be the primary promotion within the booth. Non-exhibitors' components or ancillary products or services may be incorporated in an exhibitor's booth as long as those products or services are used in their roles as equipment, supplies or services needed to demonstrate an exhibitor's product.
7. The hours of exhibit are 10 a.m. to 6:30 p.m. Tuesday, May 17 and Wednesday, May 18, and 10 a.m. to 3 p.m. on Thursday, May 19. The floor will be open for set-up from 1 p.m. to 10 p.m. on Monday, May 16, and for tear down on Thursday, May 19 from 3 p.m. to 9 p.m.
